Data Field	Type	Description
Agency/Entity Name	Text	The Queensland Government department or agency leading the project, program of work, or requirement.
Business unit	Text	Specific business unit/branch within the agency
Category groups	Text	The Queensland Government coordinates and manages whole-of-government procurement activity through 6 category groups of spend, managed by lead agencies. Read more about our category management approach.
Sub-Category Group	Text	Sub-category of the category groups e.g. Building Contractors etc
Procurement/Project Description	Text	A meaningful and detailed description of the project, program of work or requirement.
Estimated timing for release to market	Text	The date that the project, program of work or requirement is estimated to be released to market. Note: These dates are subject to change and not all projects or requirements published in the Forward Procurement Pipeline will be released to the open market.
Flexible Procurement Method	Text	As per Clause 7 of BQ23, 'Flexible procurement' techniques may be used to pursue relevant government economic, ethical, social, and environmental objectives and targets set out in Principle 1, and innovation. These include 'limited offer method' and 'set-asides'. If 'procurement' is disclosed on the 'Forward Procurement Pipeline' and a flexible 'procurement' technique is used, it must be stated on the Pipeline
Estimated Value	Decimal	The estimated spend of the project, program of work, or requirement. Values are in Australian Dollars (GST exclusive). Funding status	Text	The status of the funding for the project, program of work or requirement. Note: Funding statuses are subject to change. If you do not know, please select N/A
